

LEGAL NOTICE **INVITATION TO BID**

Village of Wadsworth **Wadsworth Village & Orchard Parks Project**

The Village of Wadsworth (the "Village") is accepting sealed bids for the Wadsworth Village & Orchard Parks Project, which includes the renovation of two playgrounds and a tennis / basketball court for the Village of Wadsworth. The work scope will include the removal of existing playground equipment, surfacing, edging, asphalt path, fencing, asphalt milling, along with the installation of new asphalt court surfacing, color coating, asphalt seal coating, concrete walks, concrete curb, tennis fencing, playground equipment, wood fiber fall surfacing, concrete baggo goals, wood shelter, underdrainage, landscape plantings, and seed/sod restoration.

A non-mandatory pre-bid meeting will be held on **Tuesday, April 10, 2018 at 11:00 AM** at the Village's Administrative Office located at 14155 Wadsworth Rd., Wadsworth, IL 60083. Attendance is Strongly Encouraged.

The Village reserves the right to accept or reject any and all bids, waive technicalities and select a bid that meets the specifications required by the Village.

A Bid Guarantee is required to be submitted with the Bid in the amount of 10% of the Contract Bid Amount. Failure to furnish a Bid Guarantee in the proper form and amount, by the time set for opening of bids, will render the bid non-responsive and ineligible for acceptance.

Bids are to be addressed to the Village of Wadsworth, attn: Moses Amidei, 14155 Wadsworth Rd., Wadsworth, IL 60083 and shall be marked "**Sealed Bid- Wadsworth Village & Orchard Parks Project**".

Bids must be received on or before **11:00 AM, Wednesday, April 25, 2018**, at the Village's Administrative Office listed above, at which time they will be publicly opened and read aloud.

All bidders must comply with applicable Illinois law requiring the payment of prevailing wages to all laborers, workers and mechanics, as determined by the Illinois Department of Labor, and the record keeping, submission and inspection requirements of the Illinois Prevailing Wage Act, including the requirement for submission of certified payroll records. All bidders must also comply with the Illinois statutory requirements regarding labor, including equal employment opportunity laws. The successful bidder will be required to furnish a satisfactory Performance Bond and Labor and Material Payment Bond for 100% of the total Contract Amount.

The Village encourages women and minority business firms to submit bids and encourages bidders to utilize minority businesses for supplies, equipment and services.
